Tribal Council Formal Code of Ethics on Election:

Secretary/Treasurer LaRoque referenced the memo to the RBC. RBC in consensus and will sign the referenced memo.

New Business

Resolution Gaming Commission ~ Addendum to Tribal-State Blackjack Compact:

Christie Haverkamp provided a brief overview of the addendum to the Tribal State Blackjack Compact. Motion made by Michael LaRoque to approve Resolution No. 090-24-003; second by Eugene Sommers. Motion carried: 4 for, 0 against.

Tammie Poitra, Regional Director BIA Letter:

Secretary/Treasurer LaRoque referenced the letter to the RBC.

Motion made by Eugene Sommers to approve; second by Cheryl "Annie" Jackson. Motion carried: 4 for, 0 against.

Elder Homeowner Repair Program:

\$300,000 was provided to each district for homeowner repairs. No funding was offered to off reservation tribal members at that time. Secretary/Treasurer LaRoque commented on completing Phase 1. A spreadsheet was sent to the Tribal Council on their current projects with all the information sent to White Earth Builders. After the election, Secretary/Treasurer LaRoque would like to move forward with Phase II and to find more funding resources for the Homeowner Repair Program. The District Representatives had several applications turned in. Recommendation to finish Phase I and move onto Phase II working directly with White Earth Builders. RBC in consensus.

Land Lots:

A brief discussion was held on our constituents having no way of clearing their homesites or to put in their own driveways. RBC needs to find funding for this purpose. Recommendation to work with forestry, roads, and water & sewer. Tribal members do not have the money to do this work. Recommendation to find resources and funding to assist with the costs. A brief discussion was held on existing lots that have been abandoned and currently cleaned.

Representative Sommers commented on homesites in District II. Recommendation to search for EPA funding to help with these home sites.

Donation Request for Youth Summer Basketball Tournaments:

Recommendation to work with the Youth and Elder fund Committee for these donations. A brief discussion was held on traveling basketball teams and sponsoring these events. Recommendation to meet with Curtis on Monday regarding the traveling basketball teams.

AU Team put in a request to Representative Sommers. The request is for 9 of our youth to attend a tournament. They will have the exposure for college recruits. Requested amount: \$6,000, this will include flights, food, hotel, and car rental. Representative Sommers will refer to the Youth and Elder Fund Committee for this request. A brief discussion on setting aside funds for youth for sports.

I.H.S Letter of Intent; Resolution Intent to Incur Pre-Award and Startup Costs – I.H.S:

Media Press Releases:

A brief discussion was held on the actions that the Tribal Council approves of. Secretary/Treasurer LaRoque brought forward concerns regarding tribal members finding out from other entities on these actions and being misinformed.

Secretary/Treasurer LaRoque commented on having our media work with the Chairman for press releases to keep the membership informed and updated for transparency on the decisions that the Tribal Council makes. White Earth will work with our own media for this purpose. The Tribal Council attends many events and needs to be proactive. Secretary/Treasurer LaRoque stated the Chairman speaks for the White Earth Band and the updates need to come from our chairman for media releases and we need to start utilizing the media outlets.

Laurie stated White Earth is getting a new website, and an Intern will be joining the media team to help assist in these areas.

A brief discussion held on the A.I. Representative Jackson commented on how many of our members do not use computers and how to get the information out to membership. A brief discussion was held on the new Teams phones.

COLA Requested Twins Tickets:

COLA is requesting 25-30 tickets for incentives for students at \$14.00 dollars per ticket. These tickets will be through the Shooting Star Casino.
